## Scholarship Information 2026-2027

The Juneau Montessori School values and supports all families. We are pleased to offer our families a scholarship program. Scholarships awards cover one academic year (September – August). Returning families requesting scholarships need to re-apply each year.

If a family has multiple children enrolled at the school, the oldest child will receive a sibling discount of \$85/month.

The number of scholarships awarded, as well as the value of each individual scholarship is based on the following criteria:

1. The availability of scholarship funds
2. The number of scholarship applicants
3. The family's size and adjusted gross income (i.e. Line 4 on Form 1040EZ, Line 2 on Form 1040A, or line 37 on Form 1040)

### APPLICATION PROCESS

To be considered for a scholarship, return a completed application along with **the first page of your 2025 tax return** to [jms@juneaumontessori.org](mailto:jms@juneaumontessori.org) or drop it in our mailbox at 750 St. Ann’s Ave, Douglas AK 99824.

If you are applying for a scholarship for multiple children, please fill out one application for each child. If you receive a scholarship and your financial situation changes (improves or worsens), please contact the school so that your scholarship can be adjusted as needed. Families who enroll in the school mid-year or who find themselves in need mid-year are encouraged to apply at that time.

If your family receives a scholarship, it will be applied directly to your tuition bill each month, and you will be responsible for paying the remaining portion of your bill.

### CONFIDENTIALITY

Scholarship applications are kept strictly confidential and are reviewed solely by the Executive Director and Treasurer.

Scholarship decisions will be communicated to applicants by email.
